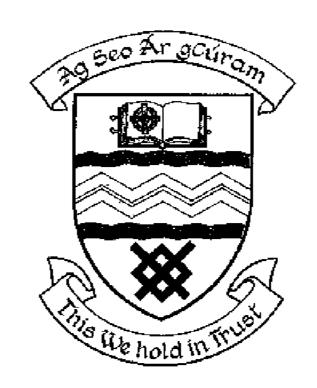

With reference to your planning application, received on 06/02/97 in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning & Development) Acts 1963-1993, the following ADDITIONAL INFORMATION must be submitted in quadruplicate:

- There is an existing evergreen hedge and a line of poplar and other trees running adjacent to and on the applicants side of the existing chain link fence which represents the boundary of the property. The applicant is asked to clarify his intentions with regard to this evergreen hedge and row of trees.
- The Planning Authority is of the opinion that this hedge and row of trees should be preserved and are concerned that the excavation for the foundations of the new wall will interfere with the roots of the hedge and trees. It would be impossible to dig the foundations for the wall by means of a mechanical digger without interference with the hedge and trees unless the excavations were carried out from outside the applicants property. The applicant is asked to carry out a hedge and tree survey and show the effect of the proposed development on the hedge and trees, and to show how the development is to be achieved.
