

#### Reasons

- The Development Plan states in Section 3.5.6 "that the minimum garden depth of 11m for two-storey houses may be reduced to 7m for single storey dwellings subject to the maintenance of privacy". The proposed development which extends along the side boundary with no. 245 for a distance of 21m would result in a garden depth of 3m from its rear building line. The proposed development, by reason of its scale and extent and relationship with adjoining properties to the rear and to the side constitutes substandard development and is contrary to the zoning objective of the area, 'to protect and improve residential amenity'. The proposed development would seriously injure the amenities and depreciate the value of property in the vicinity.
- The proposed development comprises accommodation for a selfcontained unit and extension to the front. The nature and extent of the proposed development is not described adequately and the application is therefore misleading and is not in accordance with the requirements of the Local Government (Planning and Development) Regulations 1994.
- The proposed development by reason of its encroachment on the building line constitutes disorderly development and is contrary to the proper planning and development of the area.
