

Reasons

- The site is located in an area zoned "to protect and provide for the development of agriculture", as expressed in the 1993 Dublin County Development Plan for the area. It is the policy of the planning authority, as set out in the plan, to restrict housing development in this area to persons who can establish a genuine need to reside in proximity to their employment where related to the rural community, or reasons of close family ties with the rural community. The proposed development would conflict with the policy and would, therefore, be contrary to the proper planning and development of the area.
- The proposed development contravenes the adopted policies of South Dublin County Council (paragraph 2.5.2.ii and 2.5.2.iii, 1993 Dublin County Development Plan) and the Department of Environment (paragraph 3.19, "Development Control Advice and Guidelines, October 1982, and paragraph 3.5, "Policy and Planning Framework for Roads", January, 1985) in relation to access onto National Routes. The proposed development would, therefore, be contrary to the proper planning and development of the area.
- The proposed development by itself and by the precedent which the grant of permission for it would set for other relevant development, would adversely affect the use of a National Road by traffic.
- The proposed development would generate additional traffic turning movements on the N81, Blessington Road. It would,

therefore, endanger public safety by reason of traffic hazard and obstruction of road users.

- The proposed development would constitute undesirable ribbon development on a National Secondary Road which would lead to demands for the uneconomic provision of services. The proposed development would, therefore, be contrary to the proper planning and development of the area.
- The proposed house by virtue of its bulk, height and location on the site would interfere with a view listed for preservation in the 1993 Dublin County Development Plan (see Map. No. 21) and as such would seriously injure the amenities of the area.
