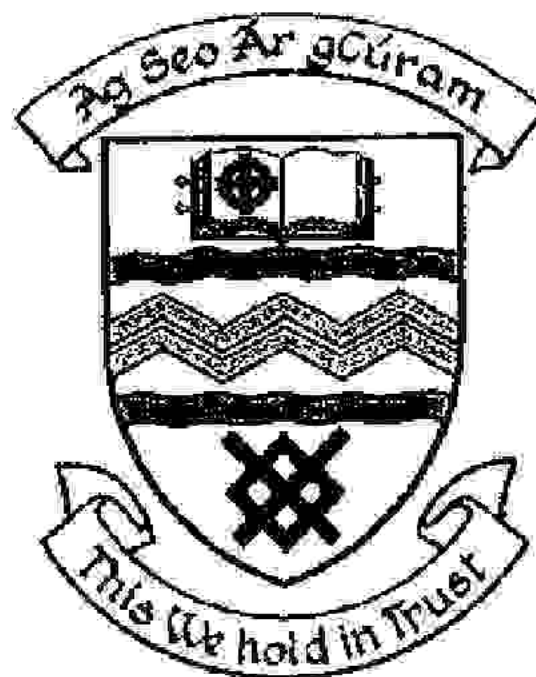

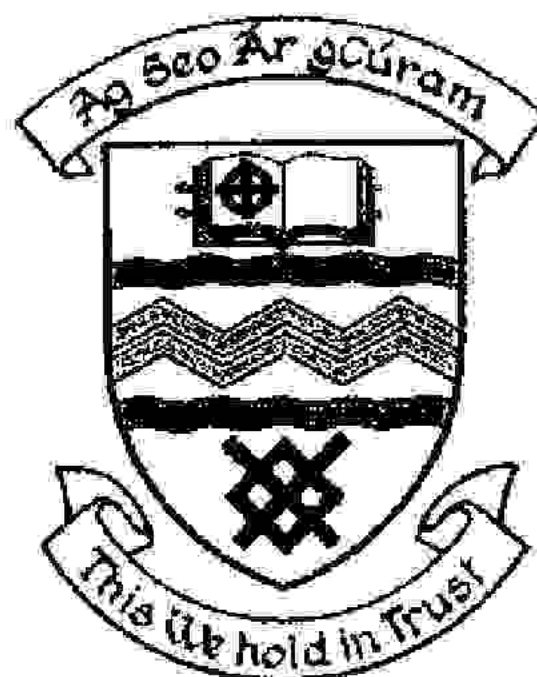

- 1 The development to be carried out in its entirety in accordance with the plans, particulars and specifications lodged with the application, save as may be required by the other conditions attached hereto.

REASON:

To ensure that the development shall be in accordance with the permission and that effective control be maintained.

- 2 That the water supply and drainage arrangements, including the disposal of surface water, be in accordance with the requirements of the South Dublin County Council.

- 3 That prior to commencement of development the requirements of the Principal Environmental Health Officer be ascertained and strictly adhered to in the development. 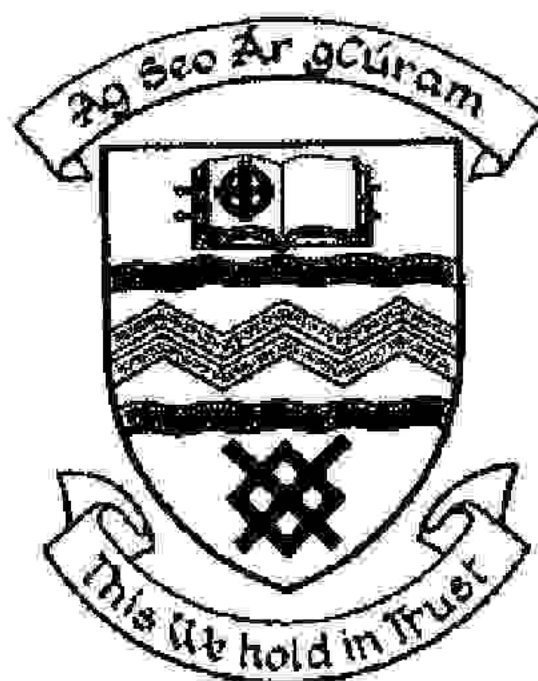

With reference to your planning application, received on 19/12/97 in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning & Development) Acts 1963-1993, the following **ADDITIONAL INFORMATION** must be submitted in quadruplicate:

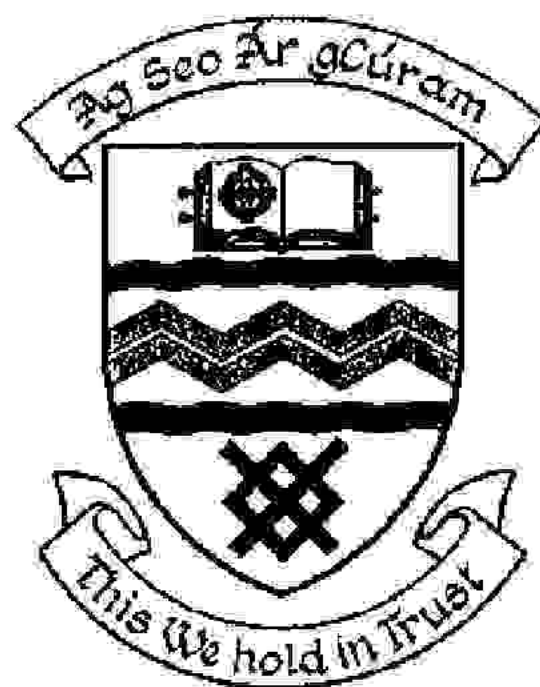
- 1 Applicant is requested to submit a block plan of scale 1:500 showing the location of the shedding in relation to the Griffeen River and any other watercourses in the vicinity of the site. Applicant to submit details of proposals to safeguard the Griffeen River and any other watercourses from potential pollution caused by the proposed development.
- 2 Applicant is requested to submit details of the number and age of livestock that it is proposed to house, the capacity of the slurry holding area for the number of livestock and details of the basis upon which this capacity was calculated.
- 3 Applicant is requested to submit details of method of final disposal of slurry. In the event of spreading of slurry, applicant to submit a map of adequate scale indicating the area of spreading, the location of watercourses in relation
