Reasons

- The proposed development of a second house on this site 1 unrelated to agricultural use or need would contravene materially a development objective of the 1993 Dublin County Development Plan for the use primarily of the site for agricultural purposes. The proposed development would result in haphazard one-off housing on agricultural lands which would injure the rural character of the area.
