

Reasons

- The proposed development would contravene materially a development objective indicated in the Dublin County Development Plan 1993 for the use solely or primarily of particular areas for particular purposes i.e. zoning objective B; To protect and provide for the development of agriculture in the Dublin County Development Plan 1993. The applicant has not submitted any documentation that the proposed development would be compatible with this zoning objective.
- The proposed development would contravene the policies of the Dublin County Development Plan 1993 regarding dwellings in rural areas as set out in paragraph 2.3.6 of the said Development Plan.
- The proposed development by reason of substandard visibility at the entrance and substandard surrounding road network, would endanger public safety by reason of traffic hazard.
- The proposed development by reason of substandard and inadequate on site effluent treatment would be prejudicial to public health. A trial hole inspected on site on 16.12.97 indicated that the soil is not suitable for the treatment and percolation of septic tank effluent.
- Development of the kind proposed would be premature by reference to the existing deficiency in the provision of sewerage facilities to serve the site and the period within which the constraints involved may reasonably be expected to cease.
