


- 1 It was noted on a site visit that the subject shop is now in use as an English Language School. The applicant is advised that this change of use is unauthorised and should be regularised by way of a formal application for permission for its retention. New site notices and newspaper advertisements would be required to be submitted accordingly.
- 2 The applicant is requested to submit full details of proposed drainage system including pipe sizes, gradients, cover and invert levels, up to and including connection to public system. In this regard, the applicant is requested to submit a letter of consent from the owner of the adjoining site if it is proposed to connect into a foul sewer which lies across his land.
