Reasons

- The site of the proposed development is located in an area designated as an area of high amenity with the zoning objective 'G', that is, "to protect and improve high amenity areas", as expressed in the current development plan for the area. It is a policy of the planning authority, as set out in the plan, that housing will only be permitted in areas of high amenity where the applicant is a native of the area and can demonstrate a genuine need for housing in the area and subject to other development control objectives. It is considered that the proposed development would contravene materially this policy, and would, therefore, be contrary to the proper planning and development of the area.
- The proposed development constitutes undesirable ribbon development on a substandard rural road network which would lead to a demand for the uneconomic provision of services and would set an undesirable precedent for further similar development in the area. The proposed development would, therefore, be contrary to the proper planning and development of the area.
- It is considered that the additional traffic generated by the proposed development which would be located on a substandard rural road network where a considerable amount of one-off housing development has already taken place, would endanger public safety by reason of traffic hazard and obstruction of road users.
