

## Reasons

- The proposed development, by reason of inadequate provision for private open space for the proposed house and the house approved under Reg. Ref. s97A/0417 and No. 75 Limekiln Avenue constitutes substandard development which contravenes materially the provision of the Development Plan and would seriously injure the amenities and depreciate the value of property in the vicinity. The proposed development contravenes materially the zoning objective "to protect and improve residential amenity" and is not consistent with the proper planning and development of the area.
- The proposed development relates to part of a site for an approved house and would thereby contravene materially condition no. 1 of permission granted for development under Reg. Ref. S97A/0417.
- The proposed development, by reason of site layout and relationship with adjacent property, density and house design is not in keeping with the character of the area and constitutes disorderly development which would not be consistent with the proper planning and development of the area, and would depreciate the value of property in the vicinity.
