


Reasons

- The proposed development by reason of its type, size, scale, proximity to the Naas Road creates a visual impact which will cause a significant distraction to road users. The proposed development would thereby endanger public safety by reason of traffic hazard. The proposed development contravenes materially the objectives of the Dublin County Development Plan 1993 as set out in section 2.9.4 and 3.7.1. It is not consistent with the proper planning and development of the area.
- The proposed development, by itself and by the precedent which the grant of permission would set for other similar development, would adversely affect the use and visual amenities of the Naas Road.
- The proposed development by reason of its type, bulk, size, scale, relationship with existing signage and proximity to the Naas Road creates an impression of clutter and constitutes disorderly development. The proposed development is prejudicial to the visual amenity of the area and is not consistent with the proper planning and development of the area.
- Insufficient information has been submitted with regard to the proposed wall and railing, in that vehicular access is not indicated nor is there clarity as to whether or not the proposed wall follows property boundary or not, and as to access maintenance etc.


