## Reasons

- The proposed development would result in a two storey premises intensifying the level of overshadowing of the rear garden of an adjacent dwelling house and would intensify car parking in an area adjacent to this dwelling house and in an area not previously designated for such use. The proposed development, by reason of its relationship with adjacent residential development would seriously injure the amenities and depreciate the value of property in the vicinity.
- The proposed development would require additional car parking in an area not previously designated for such use and which would otherwise be suited to landscaping. The proposed development would thereby constitute overdevelopment of a site which would be substandard and contrary to the proper planning and development of the area.
