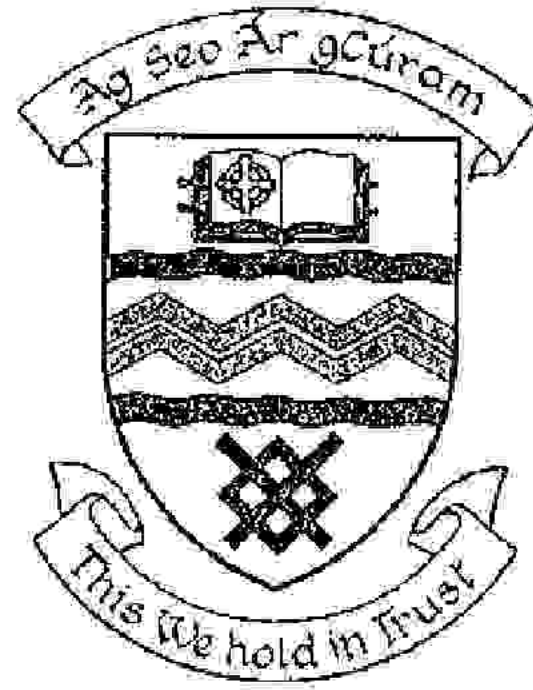

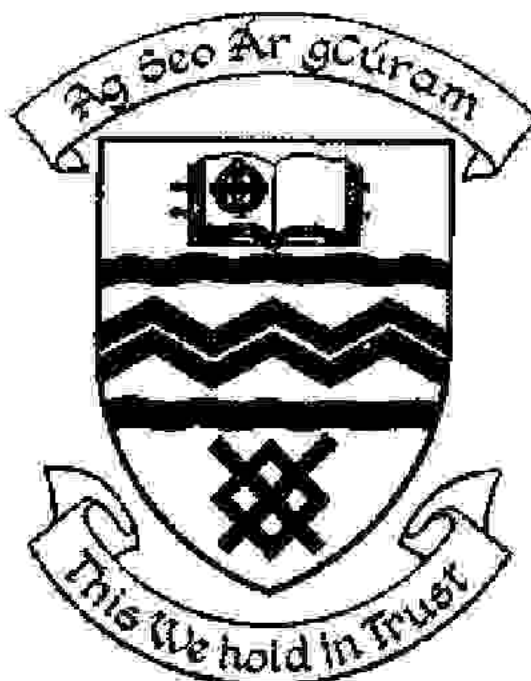

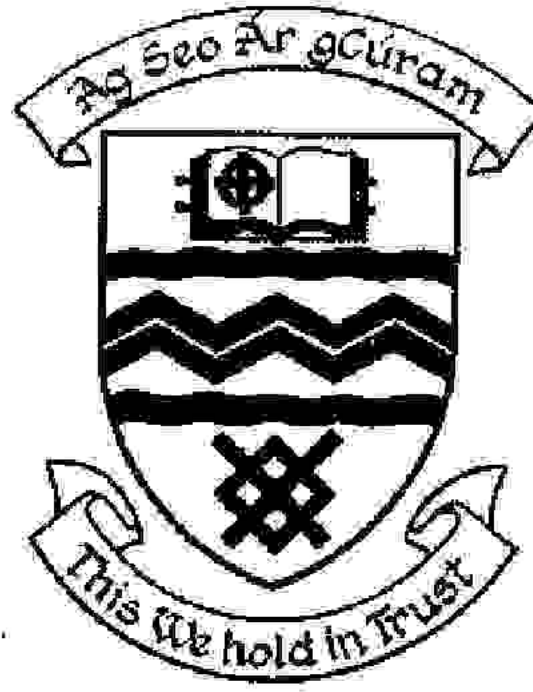

With reference to your planning application, received on 25/09/97 in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning & Development) Acts 1963-1993, the following **ADDITIONAL INFORMATION** must be submitted in quadruplicate:

- 1 The applicant is requested to submit a site layout plan to scale 1:500 or greater to show clearly all buildings and boundaries within the larger Windsor site. The applicant should clearly indicate current boundaries and current boundary treatments and indicate which are to be removed. The applicant should further indicate the proposed boundary treatments for the extended areas, the subject of this application, paying particular attention to the need to preserve the amenities of adjoining properties.
- 2 The applicant is requested to submit a surface water drainage layout for the proposed extended parking areas to show pipe sizes, gradients, invert and cover levels up to and including connection points to public surface water sewer(s).

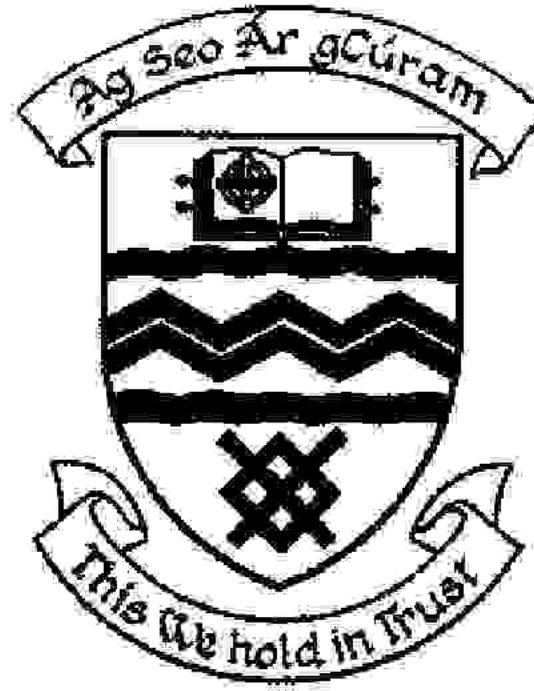
