DECISION: Pursuant to the Local Government (Planning and Development) Acts, 1963 to 1998, permission is hereby refused for the said development for the reasons set out in the Schedule hereto.

SCHEDULE

- Having regard to the location of the site of the proposed development adjacent to a structure whose preservation is an objective of the current Dublin County Development Plan (which objective is considered reasonable), it is considered that the proposed telecommunications mast, by reason of its height and design, would detract from the setting and visual integrity of this listed structure and would accordingly be contrary to the guidelines of the Department of the Environment and Local Government contained in the document "Telecommunications Antennae and Support Structures Guidelines for Planning Authorities", the policies of the Dublin County Development Plan and the proper planning and development of the area.
- Having regard to the existence of other mobile telecommunications masts in the vicinity of the appeal site, the observations contained in the document "Telecommunications Antennae and Support Structures Guidelines for Planning Authorities" in relation to co-location and the absence of details as to the consideration and/or rejection of specific co- location alternatives for the proposed development, the Board is not satisfied, on the basis of the submissions made in connection with the appeal, that the proposed development would not give rise to a proliferation of antennae support structures in a limited and elevated area which would injure the visual amenities of the area. The proposed development would, therefore, be contrary to the proper planning and development of the area.


