Reasons

- The site which is the subject of this application was designed to serve as an ancillary function to the existing shop at the front. Permission for a store was granted subject to a Condition No. 5:- That the proposed store be used solely for purposes in conjunction with the retail chemists business in the adjoining premises. The proposed development would contravene Condition No. 5 of grant of permission relative to Reg. Ref. RA79. It is considered reasonable that any store on the site should be ancillary to the shop at the front.
