



Reasons

- Having regard to the objective of the Liffey Valley Special Amenity Area Order for the prevention and limitation of development detailed in schedule 2 of the said Order, it is considered that the development by reason of it's nature and intensification of use is not consistent with and would conflict with the provisions of the Order. It is therefore considered that the development is contrary to the proper planning and development of the area.
- The development contravenes materially a development objective indicated in the Development Plan for the use solely or primarily of particular areas for particular purposes i.e. zoning objective G; "To protect and improve high amenity areas" in the Dublin County Development Plan 1993, and also the provisions of the special amenity area order.
- The proposal has created an undesirable and unnecessary additional traffic hazard on Chapel Hill by the dropping off and collecting of pupils at a bend on a steep gradient. The proposed vehicular access through the car park of St. Mary's Boys School is not within the control of the applicants and is liable to be blocked by parked vehicles during school hours.
