

Reasons

- The proposed development by reason of the inadequate provision of private open space for both the existing and proposed house constitutes substandard development and is contrary to the provisions of the development plan in this regard. The proposed development would seriously injure the amenities and depreciate the value of property in the vicinity. In this regard the Development Plan generally requires the following:— Minimum front garden depth of 7.5 metres, minimum rear garden depth of 11 metres for existing and proposed house, a minimum of 1.15 separation from side boundaries.
- The proposed development by reason of design, roof profile an external finishes is out of character with the prevailing pattern of residential development of the area. The proposed development represents disorderly development which would detract from the amenities of the area. The proposed development is not consistent with the proper planning and development of the area.
