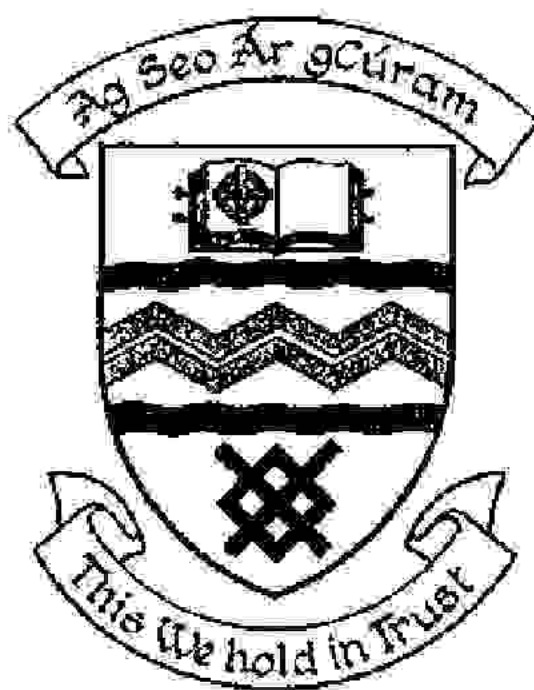

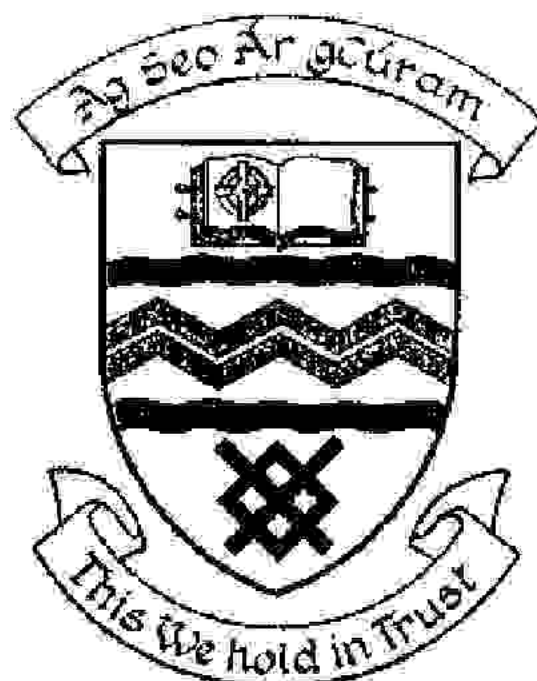

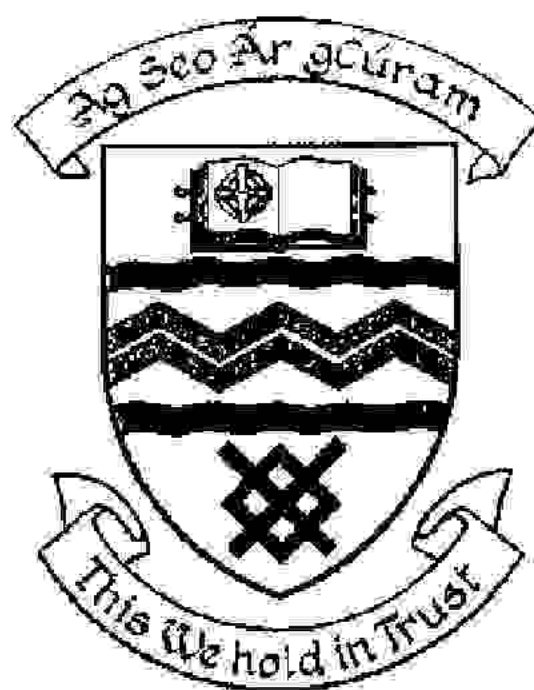
- 1 The applicant is requested to submit 1:2500 site location plan with the application site clearly identified.
