Reasons

- The proposed development by virtue of its position, height, size, bulk and design taken together with the absence of screen planting would be unduly obtrusive when viewed from the Firhouse Road and public open space north of the River Dodder and as such would be contrary to the zoning objective in the 1993 County Development Plan for the area 'to protect and improve high amenity areas', would be detrimental to the visual amenities of the area and contrary to the proper planning and development of the area.
- The proposal to share an existing vehicular entrance which has substandard vision to the south would, in the absence of a reconfigured entrance, be likely to cause a traffic hazard.
