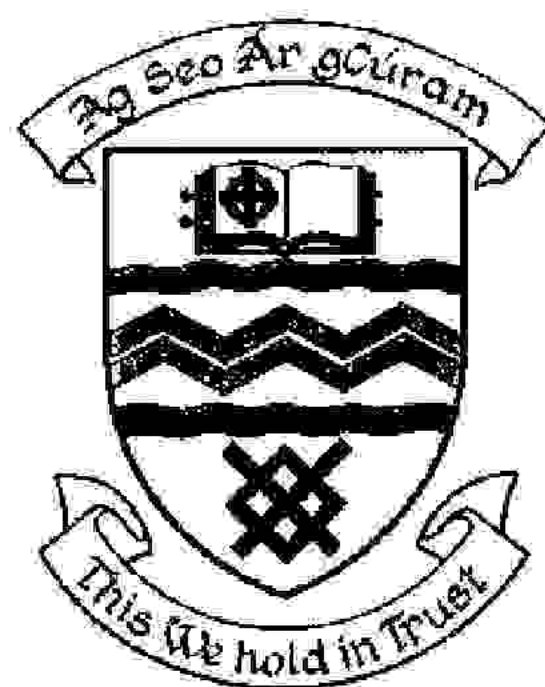

**Reasons**
