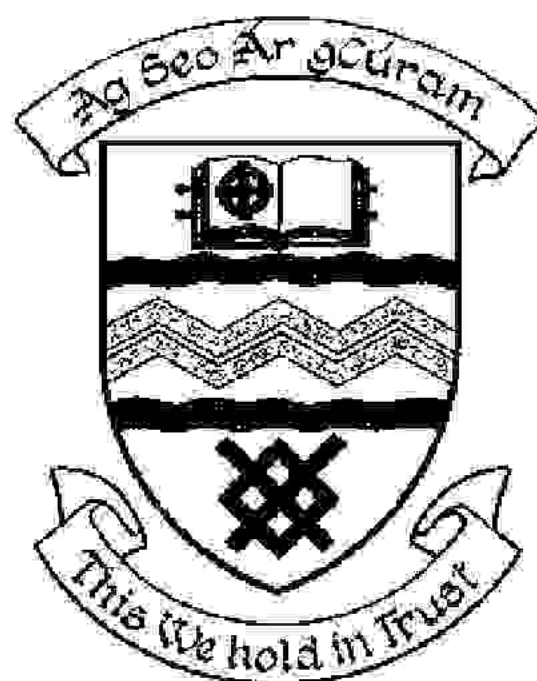

**Conditions and Reasons**

- 1 The development to be carried out in its entirety in accordance with the plans, particulars and specifications lodged with the application, save as may be required by the other conditions attached hereto.  
REASON:  
To ensure that the development shall be in accordance with the permission and that effective control be maintained.
  - 2 All palisade fencing shall be painted a dark colour.  
REASON:  
In the interest of visual amenity.
  - 3 The section of palisade fencing and anti-vandal spinners along the boundary wall with Drysdale Close shall not be erected. If required a 2.4m high palisade fence shall be erected not less than 2.0m from the north boundary wall in Drysdale Close as far as the front garden of the adjacent house. The intervening space shall be planted with hawthorn or other deciduous/evergreen screen to prevent the area being used for dumping or other anti-social behaviour.  
REASON:  
The proposal as outlined would be visually obtrusive when viewed from Drysdale Close and contrary to the proper planning and development of the area.
- 
- (1) All buildings must be designed and constructed in accordance with the Building Regulations 1991 amended 1994.
  - (2) Building Control Regulations require a Commencement Notice. A copy of the Commencement Notice is attached.
  - (3) A Fire Safety Certificate must be obtained from the Building Control Authority, where applicable.
  - (4) Free Standing Walls must be designed and constructed in accordance with IS 325: Code of Practice for use of Masonry Part 1 : Structural use of unreinforced Masonry. The owner must also ensure that the construction of all walls is supervised by a competent person.

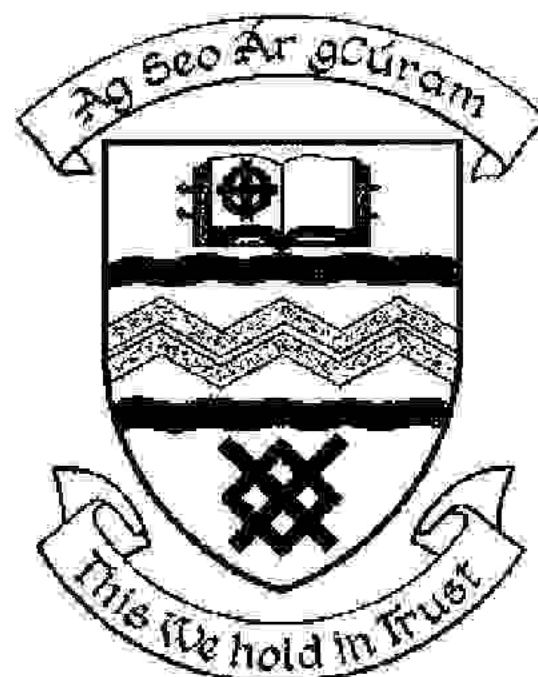
