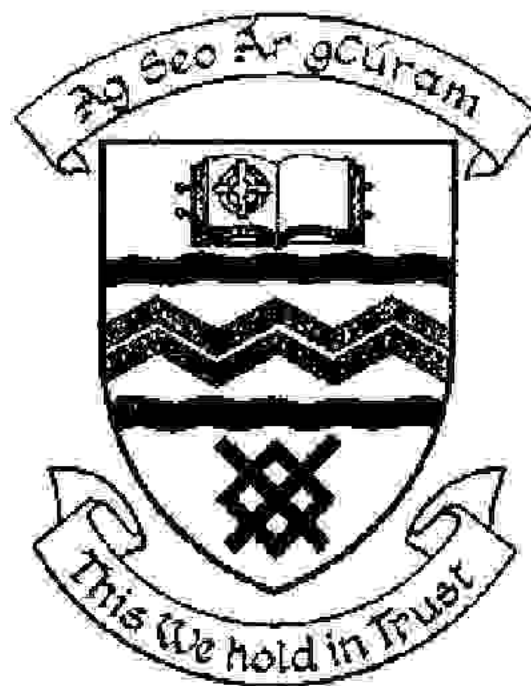

Reasons

- 1 The development contravenes materially a development objective indicated in the Development Plan for the use solely or primarily of particular areas for particular purposes i.e. zoning objective C2; To protect and enhance the special physical and social character of town and village centres in the Dublin County Development Plan 1993.
- 2 The development conflicts with the policies and objectives of the Council as set out in the Dublin County Development Plan 1993 with regard to both development within conservation areas and advertising generally. The development is therefore contrary to the proper planning and development of the area, would seriously injure the amenities and depreciate the value of property in the vicinity.
- 3 The development by reason of it's scale, unsympathetic nature and obtrusiveness would set an undesirable precedent for other similar development which would in themselves and cumulatively be contrary to the policies and objectives of the Dublin County Development Plan 1993, harmful to visual amenity and be contrary to the proper planning and development of the area.
