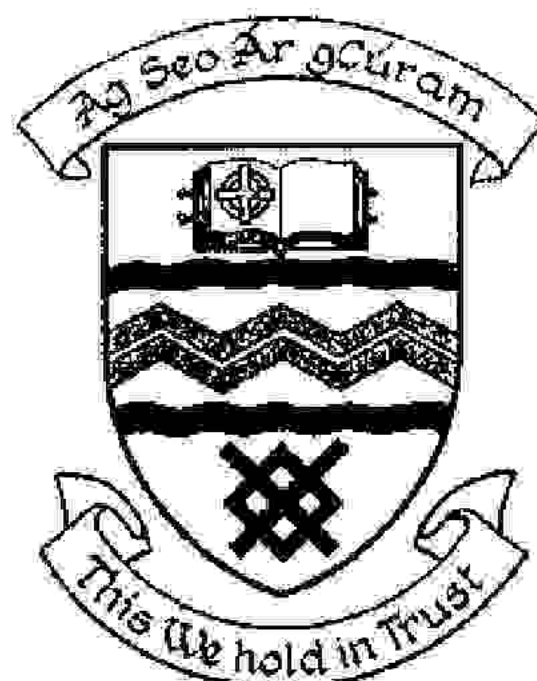

**Reasons**

- 1 The proposed development would contravene materially a development objective indicated in the Dublin County Development Plan 1993 for the use solely or primarily of particular areas for particular purposes i.e. zoning objective 'B' - "To protect and provide for the development of agriculture".
- 2 The proposed development would contravene the policies of the Dublin County Development Plan 1993 regarding dwellings in rural areas as set out in paragraph 2.3.6 of the said Development Plan in that the applicant has not established a genuine need to reside in proximity to employment which is related to the rural community nor reasons of close family ties with the rural community.
- 3 Having regard to additional traffic turning movements generated by the proposed development on the Newcastle Road R405 which experiences high traffic volumes and high traffic speeds, the proposed development would endanger public safety by reason of traffic hazard.
- 4 The proposed development, by itself and by the precedent which the grant of permission for it would set for other revelant development, would adversely affect the use of a major road by traffic (R405 Celbridge - Newcastle Road).
