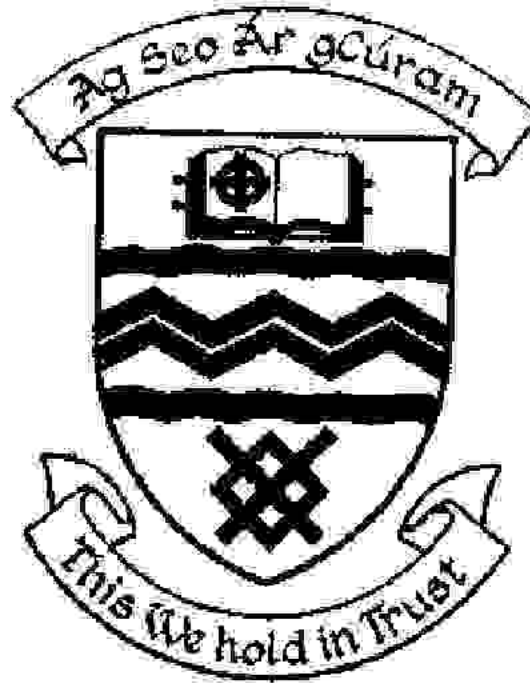

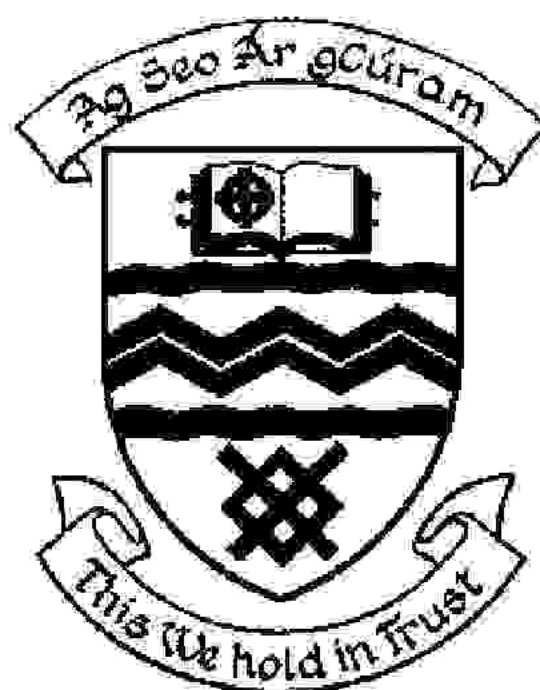

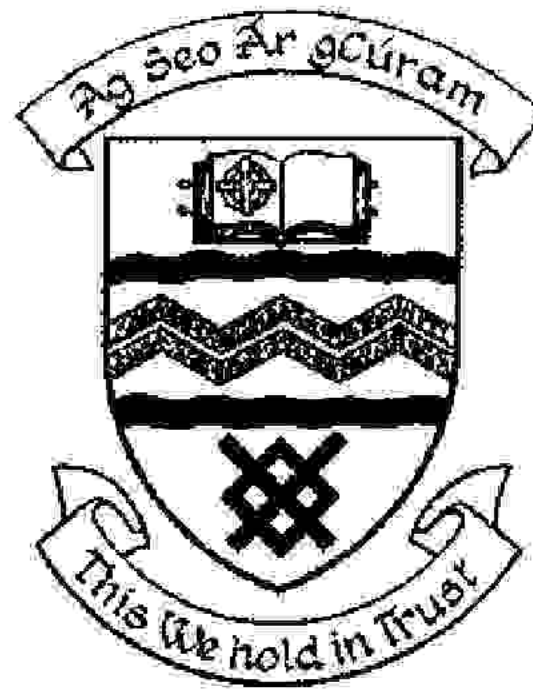

Reasons

- 1 The proposed signage by reason of its size, scale and extent and proximity to the adjoining roads is considered to be excessive and would intensify the impression of clutter in the vicinity and would cause a distraction to road users which would endanger public safety by reason of a traffic hazard. The proposed signage contravenes materially the objectives of the Development Plan set out in section 3.7 of the 1993 Development Plan.
- 2 The proposed development would set an undesirable precedent for such development which would seriously injure the visual amenities of the area and would not be consistent with the proper planning and development of the area.

The notice must be maintained in position for at least one month and must fulfill the following conditions:-

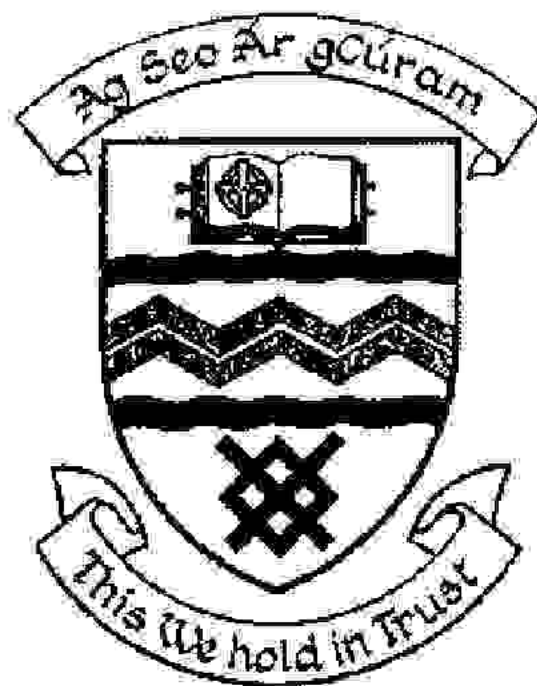
- 1. Must be durable material

- 3. Must be headed "Application to Planning Authority".
- 4. Must state:
 - (a) Applicant's name
