- 1. The existing warehouse extension is seriously affected by the Council's Reservation for the proposed Greenhills/Robinhood Road Improvement Scheme due to commence in 1984 and this would not be in accordance with the proper planning and development of the area.**
- 2. The proposed retention of the existing warehouse extension would contravene materially conditions 2 and 3 of permission granted by the Council by Order No. PA/262/82 dated 28/1/82, Reg. REF. WA.2448, and thus would not be in accordance with the proper planning and development of the area.**
