- 1 The proposed development is substandard development by reason of excessive density, inadequate provision of private open space, inadequate vehiclar access and impact on adjoining property which would seriously injure the amenties and depreciate the value of property in the vicinity. The proposed development is not consistent with the objective for the area "to protect and improve residential amenity" and is not consistent with the proper planning and development of the area.
- 2 A grant of permission would set an undesirable precedent in the area for development which is not consistent with the proper planning and development of the area.
- 3 The lack of provision of adequate off street car parking to serve the existing and proposed dwellings would lead to on-street parking which would endanger public safety by reason of traffic hazard and obstruction of road users.
