In pursuance of its functions under the above mentioned Acts the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order, P/ **A/923/83**, dated **20th April, 1983** decide to refuse:

for the following reasons:

1. The proposal to provide a new vehicular access at the side of the house site would endanger public safety by reason of a traffic hazard and would not be in accordance with the proper planning and development of the area.
2. The proposed development would materially contravene condition no. 6 of Order No. PA/227/83, dated 8/2/83, Reg. Ref. No. XA 2311, for which permission was granted for a two storey extension together with new boundary wall and garage, and would not be in accordance with the proper planning and development of the area.
