



Conditions and Reasons


- 1 The development to be carried out in its entirety in accordance with the plans, particulars and specifications lodged with the application, save as may be required by the other conditions attached hereto.  
REASON:  
To ensure that the development shall be in accordance with the permission, and that effective control be maintained.
- 2 That the entire premises be used as a single dwelling unit.  
REASON:  
To prevent unauthorised development.
- 3 That all external finishes harmonise in colour and texture with the existing premises.  
REASON:  
In the interest of visual amenity.
- 4 That adequate measures are taken by the applicant to ensure that the remaining trees on site are secure.  
REASON:  
To avoid interference with the adjoining footpath/road (Butterfield Avenue) which would be prejudicial to public safety.
- 5 The proposed garage to be used solely for purposes incidental to the enjoyment of the dwelling house as such and shall not be used for any trade <sup>OK</sup> ~~as~~ commercial use. *JS*
