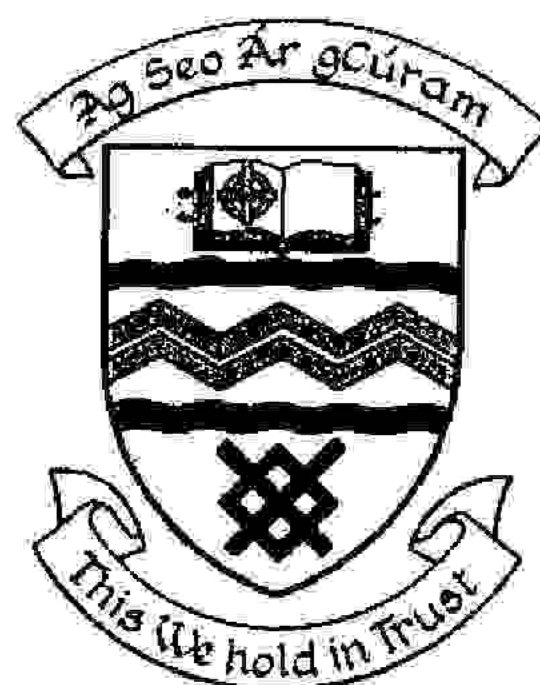

Conditions and Reasons

- 1 The development to be carried out in its entirety in accordance with the plans, particulars and specifications lodged with the application, save as may be required by the other conditions attached hereto.
REASON:
To ensure that the development shall be in accordance with the permission and that effective control be maintained.
- 2 Prior to the commencement of development details for the provision of a bus lay-by at the site of the existing bus stop shall be submitted to and be to the satisfaction of the Planning Authority. The lay-by shall be constructed to the satisfaction of the Planning Authority and shall be constructed at the same time as the installation of the bus shelter.
REASON:
In the interests of the proper planning and development of the area and assisting in the flow of traffic on the Naas Road, with particular regard to the proximity of the site to the Newlands Cross junction.
- 3 That the applicant indemnify the Council against any claim made against the Authority as a result of the presence of the structure on a public property.
REASON:
In the interests of the proper planning and development of the area.
- 4 That the applicant accepts responsibility for the removal of the structure at his own expense if such is necessary for the purposes of road widening, reconstruction or repair and for the repair, replacement and renewal of any services installed in the public road.

- 5 The structure panels shall not be lit in such a manner so as to cause excessive glare or distraction to road users or
