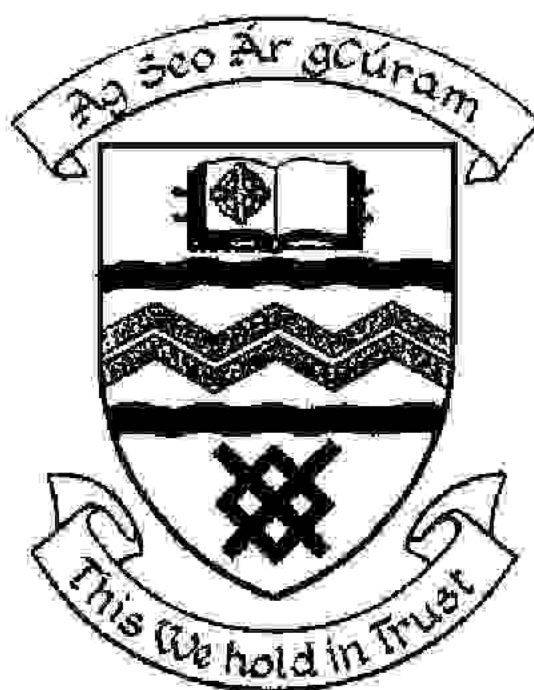

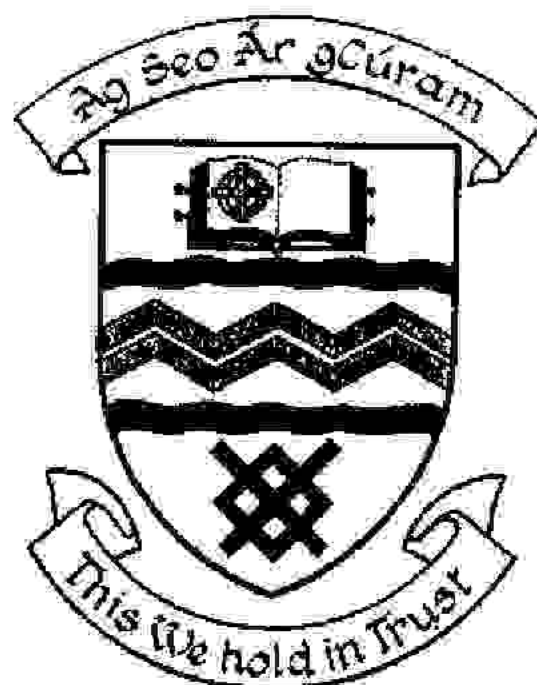
Conditions and Reasons

- 1 That the applicant indemnify the County Council against any claim made against the Authority as a result of the location of the shelter on public property.
REASON:
In the interest of the proper planning and development of the area.
 - 2 That the applicant makes satisfactory arrangements for the maintenance, repair, and upkeep of the shelter.
REASON:
In the interests of amenity and public safety.
 - 3 That the applicant accepts responsibility for the removal of the shelter at his own expense, if such is necessary, for the purpose of road widening, reconstruction or repair, and for the repair, replacement and renewal of any services installed in the public street.
REASON:
In the interests of the proper planning and development of the area.
 - 4 The panels or shelter shall not be illuminated in such a manner so as to cause excessive glare or distraction to road users, or adjoining property owners.
REASON:
In the interests of the proper planning and development of the area.
 - 5 The level of illumination to be subject to review at any time by the Council and adjustments shall be made by the applicant at his own expense if requested by the County Council.
REASON:
In the interest of the proper planning and development of the area.

- (1) All buildings must be designed and constructed in accordance with the Building Regulations 1991 amended 1994.
 - (2) Building Control Regulations require a Commencement Notice. A copy of the Commencement Notice is attached.
