**Reasons**

- 1 The proposed bus shelter is located close to the junction of Knockaire Estate and Knocklyon road. A bus shelter of the type proposed (i.e. with a side panel) would interfere with the visual splays available to traffic exiting Knockaire and would endanger public safety by reason of a traffic hazard.
