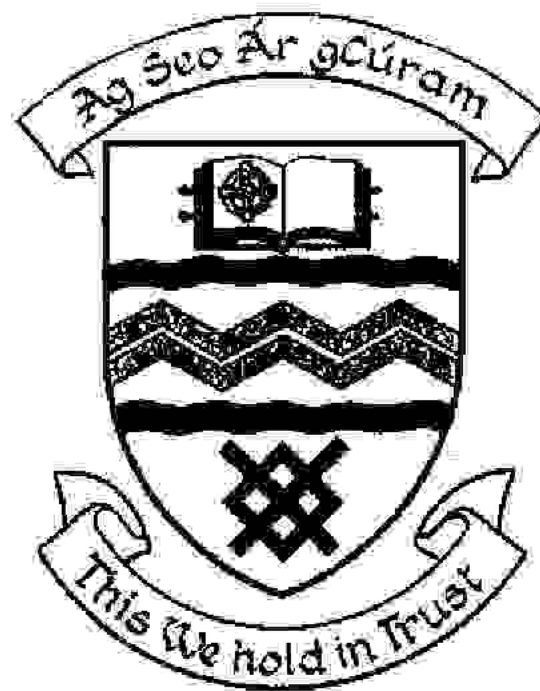

- 1 The development to be carried out in its entirety in accordance with the plans, particulars and specifications lodged with the application, save as may be required by the other conditions attached hereto.  
REASON:  
To ensure that the development shall be in accordance with the permission and that effective control be maintained.
- 2 That the applicant indemnify the County Council against any claim made against the Authority as a result of the presence of the structure on public property.  
REASON:  
In the interest of the proper planning and development of the area.
- 3 That the applicant make satisfactory arrangements for the maintenance, repair and upkeep of the structure on a public property.  
REASON:  
In the interest of public safety and visual amenity.
- 4 That the applicant accepts responsibility for the removal of the structure at his own expense if such is necessary for the purpose of road widening, reconstruction or repair and for the repair, replacement and renewal of any services installed in the public street.  
REASON:  
In the interest of the proper planning and development of the area.
- 5 The panel shall be lit in such a manner so as not to cause excessive glare or distraction to road users or adjoining property owners.  
REASON:  
In the interest of public safety and amenity.

- 6 The level of illumination to be reviewed at any time by the Roads Department and adjustments to be made by the applicants if requested by South Dublin County Council.  
REASON:  
In the interest of traffic safety.
- 7 That the hard stand area be to the requirements of the Area Engineer, Roads Department.  
REASON:  
In the interest of the proper planning and development of the area.
- (1) All buildings must be designed and constructed in accordance with the Building Regulations 1991 amended 1994.
- (2) Building Control Regulations require a Commencement Notice. A copy of the Commencement Notice is attached.
- (3) A Fire safety Certificate must be obtained from the Building Control Authority, where applicable.
- (4) Free standing Walls must be designed and constructed in accordance with IS 325: Code of Practice for use of Masonry Part 1 : Structural use of unreinforced Masonry. The Owner must also ensure that the construction of all walls is supervised by a competent person.
