The site is located within the J.F.K. Industrial Estate where at times, a considerable amount of on-street parking of trailers, containers and cars etc. take place. The proposed development would result in a loss of 4 car park spaces for the proposed extension which is already deficient by two car park spaces. This deficiency together with the existing deficiency of car parking spaces would be prejudicial to public safety by reason of a traffic hazard.
