Reasons

- 1 The site is located in an area that is designated in the 1993 Dublin County Development Plan as a 'high amenity' area and in relation to which it is a policy of the Planning Authority as set out in section 2.3.6 of the Development Plan to restrict houses to persons who are natives of the area and can demonstrate a genuine need for housing in the area. As the applicant has not established sufficient need for housing, the proposed development would materially contravene the said policy and would, accordingly, be contrary to the proper planning and development of the area.
- 2 The proposed development would endanger public safety by reason of traffic hazard because of the generation of additional traffic movements on the substandard road network serving the area.
- 3 The site is located within the catchment of the Bohernabreena Reservoir which is a major source of public water supply. It is considered that the proposed development, and the precedent for other similar development which a grant of outline permission for it would set, would pose a threat to the public water supply, would be prejudicial to public health and would, accordingly, be contrary to the proper planning and development of the area.
- 4 The proposed development could be prejudicial to public health for the following reasons:-
 - a) percolation tests have not been carried out on the site.
 - b) a reserve percolation area has not been indicated.
