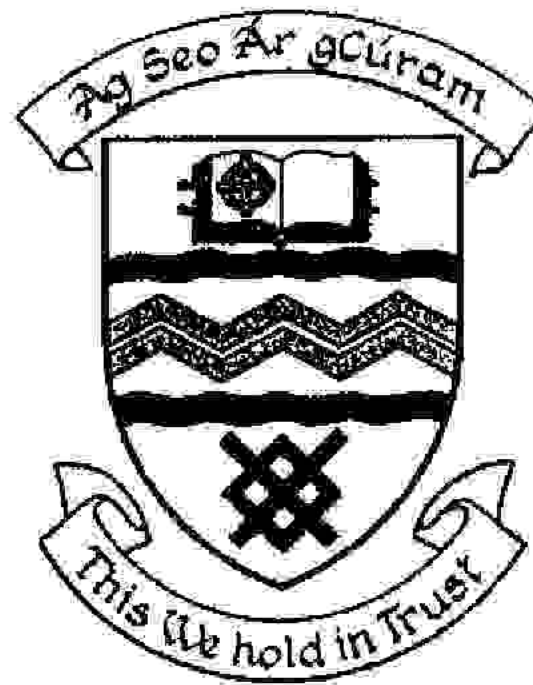

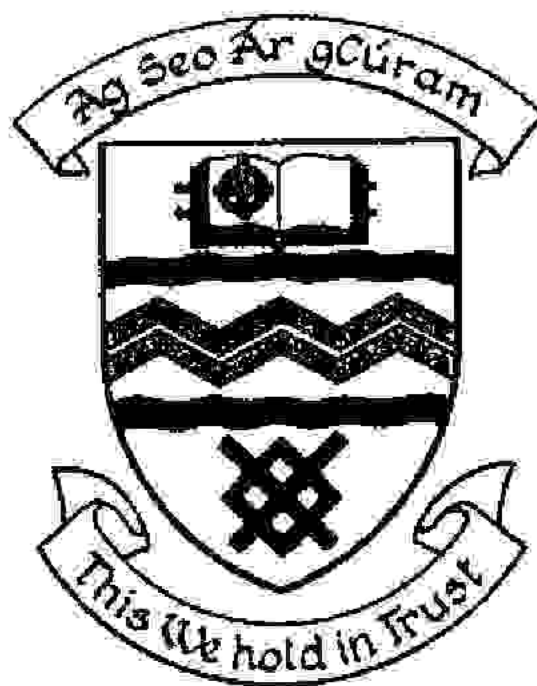

Reasons

- 1 The palisade fence, at 500m in length along a heavily trafficked National Primary Road and at a key junction in the approaches to Dublin City, Tallaght and Clondalkin, would be seriously injurious to the visual amenity of the area and contrary to the proper planning and development of the area.
