APPEAL by Newburn Limited of Star Cinema, Crumlin, Dublin against the decision made on the 23rd day of March, 1983, by the Council of the County of Dublin to grant subject to conditions a permission to Drimmagh Motors Limited of Drimmagh Road, Drimmagh, Dublin for development consisting of minor alterations to an approved extension to premises at Drimmagh Road, Drimmagh, Dublin in accordance with plans and particulars lodged with the said Council:
