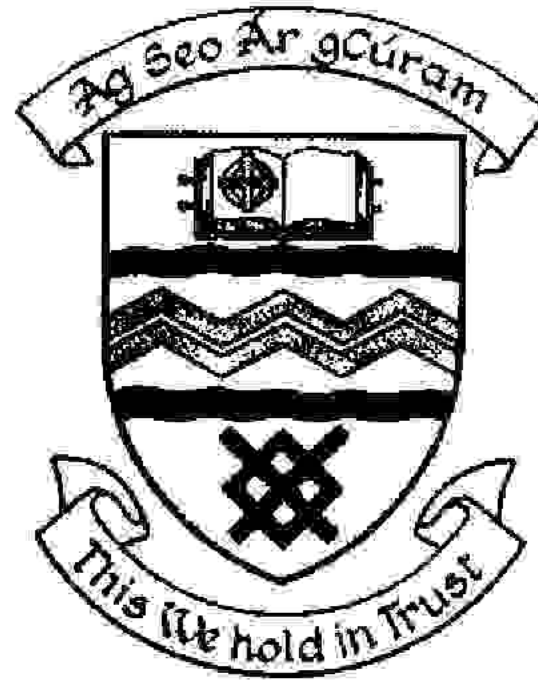
- (a) a copy of the text of the notice
