I refer to your submission received on 30.07.1998 to comply with Condition No. 28, of decision to Grant Permission, Order No. 2064, dated 23/10/96, in connection with the above.

In this regard I wish to inform you that you are required to provide a 2 metre high timber fence to the rear of the Willsbrook Woods properties along the ownership boundary. The treatment to the site boundary of Site No. 63 where it abuts a cul-de-sac and the front garden of an adjoining dwelling in the Fairways should be in the form of a 1.2 metre high retaining wall and a 2 metre high block wall capped and plastered/rendered on both sides. The remainder of the side boundary to Site no. 63 and Site No. 93 should be in the form of a 1.2 metre high retaining wall and a 2 metre high timber fence (total height of this part of the wall/fence to be 3.2 metres from the Willsbrook Woods side).
