

Dear Sir,

I refer to your submission received on 27/08/99 to comply with Condition No.'s 2, 4, 5, 6, 15 and 16 of Grant of Permission Order No. 0034, dated 09/01/97, in connection with the above.

With regard to Condition No. 16 the submitted details for the roads/parking bay construction/layout is acceptable to the Planning Authority.

In respect of submission re Condition No. 2 the substitution of three townhouse in lieu of the two storey building required by this condition would materially change the proposal which has been granted permission and therefore is not acceptable to the Planning Authority. A separate planning application for the proposed change will be required. The applicant is advised to consult with the Planning Department prior to the submission of a planning application in this regard. As a consequence, Condition No.'s 2, 4, 5, 6, and 15 remain to be complied with.
