Reasons

- The proposed development represents over development of this small site in the following manner:
 - inadequate provision has been made for off-street car parking and off-street loading and unloading facilities;
 - inadequate provisions has been made regarding open space, parking etc. relative to the existing cottage at no. 9. In this regard insufficient information has been submitted relative to the existing cottage, and the proposed development would remove all the open space amenity to the rear of the cottage;
 - inadequate building line set back has been provided to new access roadway which was designed to provide access to the rear of this site;
 - d. no provision for footpath or grass verge along the line of the existing new road has been shown on lodged plans. This would leave the proposed development seriously at variance with the approved development on the opposite side of the new road;
 - e. no evidence of the applicants right of access to new roadway has been indicated;
 - f. the proposed structure would be visually obtrusive;
 - the lack of adequate off-street car parking for the existing cottage and proposed development would result in on-street parking in the vicinity thereby endangering public safety by reason of a traffic hazard.
