AN BORD PLEANÁLA

LOCAL GOVERNMENT (PLANNING AND DEVELOPMENT) ACTS, 1963 TO 1993

APPEAL by Bord Telecom Eireann care of Reid Associates of 2 Arran Square, off Lincoln Lane, Dublin against the decision made on the 4th day of July, 1996 by the Council of the County of South Dublin to refuse permission for development comprising the erection of a 26 metre antennae structure, containerised equipment shelter and associated site works at Hillsbrook Lawns, Raheen, Brittas, County Dublin:

DECISION: Pursuant to the Local Government (Planning and Development) Acts, 1963 to 1993, permission is hereby refused for the said development for the reasons set out in the Schedule hereto.


SCHEDULE

1. The proposed 26 metre high antennae support structure located at the 310 metre contour close to the summit of a hill in an area which is zoned to 'protect and improve high amenity areas' in the current development plan for the area would be unduly obtrusive in this landscape setting by reason of its height and construction, would seriously injure the visual amenities of the area and would, therefore, contravene materially the zoning objective.
2. The proposed development would interfere with a view of special amenity value, that is, the view to the west from the Mount Seskin Road, which it is an objective to preserve, as set out in the current development plan for the area. This objective is considered reasonable. The proposed development would, therefore, seriously injure the visual amenity of the area and be contrary to the proper planning and development of the area.
