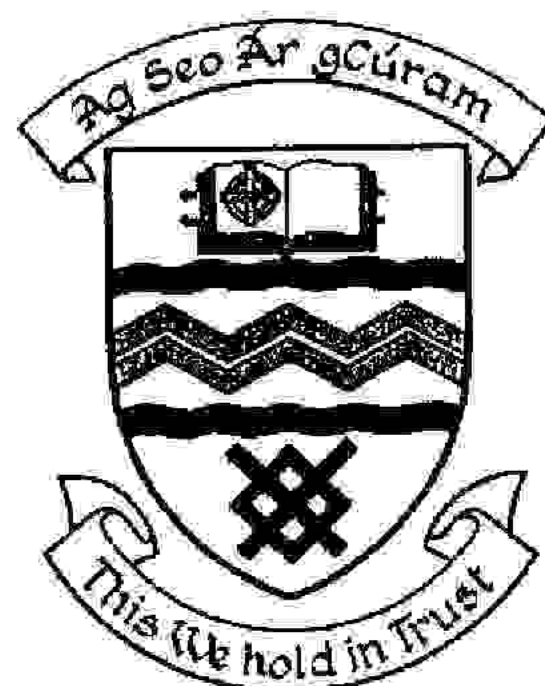

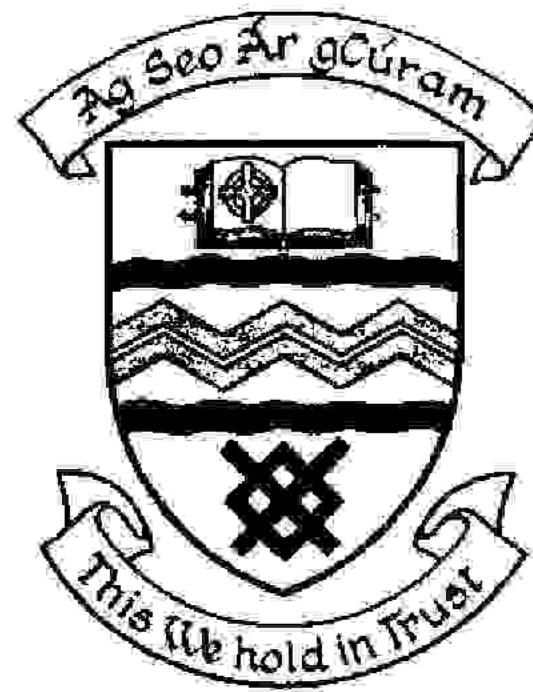

Conditions and Reasons

- 1 The development to be carried out in its entirety in accordance with the plans, particulars and specifications lodged with the application, save as may be required by the other conditions attached hereto.
REASON:
To ensure that the development shall be in accordance with the permission and that effective control be maintained.
- 2 The proposed sign structure shall provide for all the occupants of the building and that no other such sign shall be erected within the curtilage of the site.
REASON:
In the interest of visual amenity and the proper planning and development of the area.
- 3 The signage display shall be limited to the business/trade names of the occupants of the building only and shall not be used for general or product advertising. In this regard details of the individual sign panels shall be agreed in writing by the Planning Authority prior to their erection.
REASON:
In order to provide for an orderly and visually acceptable display.
- 4 That details of materials, external finishes and colours to be used be agreed in writing by the Planning Authority prior to the commencement of the development.
REASON:
In the interest of visual amenity and the proper planning and development of the area.

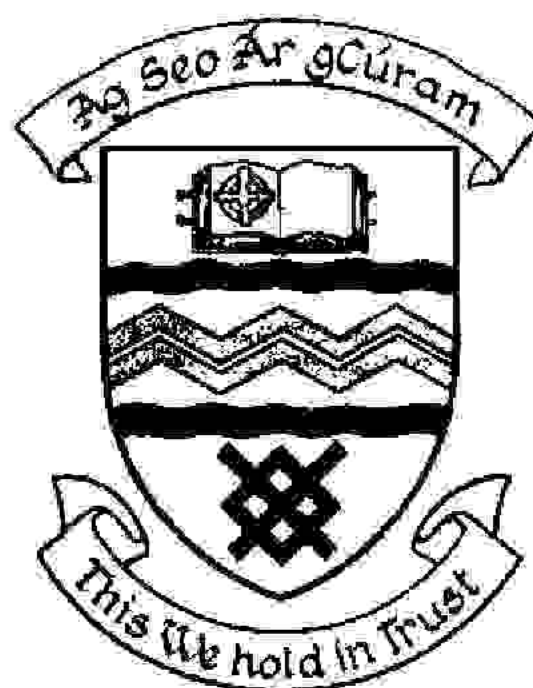
- (a) a copy of the text of the notice

3. Must be headed "Application to Planning Authority."
4. Must state:
 - (a) Applicant's name
 - (b) whether application is for Permission, Outline Permission, or Approval.
 - (c) nature and extent of development including number of dwellings (if any)
