Reasons

- That the proposed development due to its proximity to Wellignton Lane, a district distributory road would be contrary to the Council's standard set back of 15 metres for this class of road and would therefore be contrary to the proper planning and development of the area. The building line set back shown is 6 metres and this is considered to be totally inadequate.
- The proposed development is out of character with the existing residential development in the area in terms of building scale, design and provision of open space. The proposed development would, therefore, seriously injure the amenities of the area and be contrary to the proper planning and development of the area.
- The applicant has not shown an 8 metre clearance from the existing 300mm A/C watermain located on the East side of Wellington Lane.
