

The development to be carried out in its entirety in accordance with the plans, particulars and specifications lodged with the application, save as may be required by the other conditions attached hereto.

REASON:

To ensure that the development shall be in accordance with the permission and that effective control be maintained.

The development shall be carried out in conformity with Condition No's 2 to 15 incl., of the grant of permission, order No. P/780/94 dated 07.06.94 Reg. Ref. s93A/0105 save as amended to conform with the revisions indicated in the plans lodged with South Dublin County Council in connection with this application. REASON:

In the interest of the proper planning and development of the area.

That arrangements made for the payment of the financial contribution in the sum of £1,420 (one thousand four hundred and twenty pounds) per house in respect of the overall development required by Condition No. 16 of planning permission granted under Reg. Ref. S93A/0105 be strictly adhered to in respect of the above proposal. REASON:

All buildings must now be designed and constructed in accordance with the new Building Regulations. The Regulations also provide that a commencement Notice must be submitted to the Building Control Authority in respect of all buildings other than exempted development for the purposes of the Local Government (Planning and Development) Acts, 1963 - 1993, not less than seven days and not more than twenty-one days before development commences. A copy of the form of commencement notice is attached.

In addition, a Fire Certificate must be obtained from the Building Control Authority in respect of the erection, alteration or change of use of all buildings other than dwelling houses.
