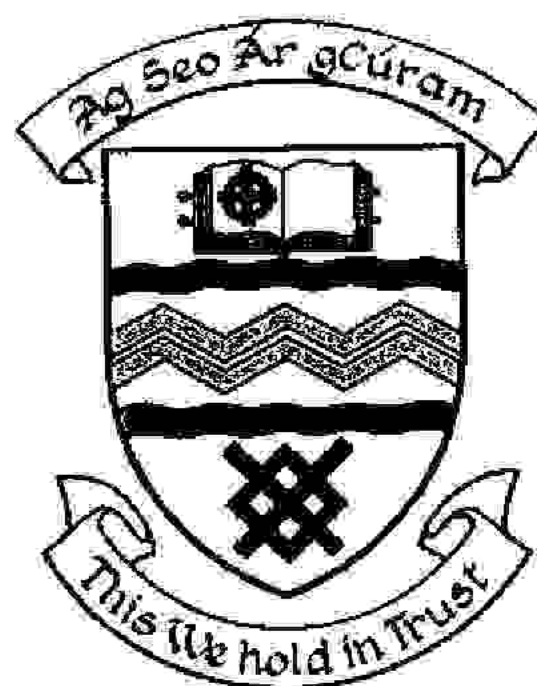

**Conditions and Reasons**

- 1 The development to be carried out in its entirety in accordance with the plans, particulars and specifications lodged with the application, save as may be required by the other conditions attached hereto.  
REASON:  
To ensure that the development shall be in accordance with the permission and that effective control be maintained.
- 2 That Mast Q1, as indicated on the 1:2500 map submitted with the application, be located as close to the stream to the west as possible. This mast shall be removed and the line to the west shall be undergrounded when the residential zoned lands to the west are developed.  
REASON:  
In the interests of visual amenity and the proper planning and development of the area.
- 3 That the precise location of mast Q2, as indicated on the 1:2500 map submitted with the application, be agreed in writing by the Planning Authority prior to the commencement of the development.  
REASON:  
In the interests of protecting the residential amenities of properties in the vicinity.
- 4 That the requirements of South Dublin County Council in relation to the protection of existing foul and surface water drains and watermains in the vicinity of the proposed undergrounding be ascertained and adhered to in the development.  
REASON:  
In the interest of the proper planning and development of the area.

All buildings must now be designed and constructed in accordance with the new Building Regulations. The Regulations also provide that a Commencement Notice must be submitted to the Building Control Authority in respect of all buildings other than exempted development for the purposes of the Local Government (Planning and Development) Acts, 1963 - 1993, not less than seven days and not more than twenty-one
