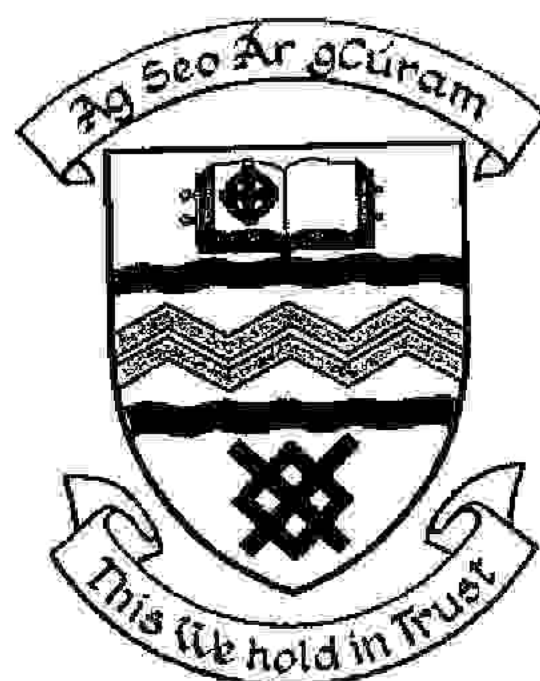

Conditions and Reasons

- 1 The development to be carried out in its entirety in accordance with the plans, particulars and specifications lodged with the application, save as may be required by the other conditions attached hereto.
REASON:
To ensure that the development shall be in accordance with the permission and that effective control be maintained.
- 2 That prior to the commencement of development details of the precise location of the proposed power line within the site of the development for which permission was granted under Reg. Ref. S95A/0468 be submitted for the written agreement in the planning authority.
REASON:
To ensure that the development is carried out in a satisfactory manner in the interest of public health.
- 3
 - a. That due care be taken of any existing public sewers crossing this site. Copies of "as constructed" drawings to be submitted to the Environmental Services Department, South Dublin County Council on completion of the proposed works.
 - b. Prior to commencement of works the applicant shall contact the supervisor at Deansrath Water Depot to agree appropriate crossings over existing services located on the sites.
REASON:
To ensure that the development is carried out in a satisfactory manner in the interest of public health.

All buildings must now be designed and constructed in accordance with the new Building Regulations. The Regulations also provide that a Commencement Notice must be submitted to the Building Control Authority in respect of all buildings other than exempted development for the purposes of the Local Government (Planning and Development) Acts, 1963 - 1993, not less than seven days and not more than twenty-one days before development commences. A copy of the form of commencement notice is attached.
