SCHEDULE

- Taken in conjunction with existing permitted development on the site since planning permission register reference number 92A/0515 granted permission for the use of the site for warehousing, the proposed transit shed would result in an undesirable expansion of development and intensification of use on a site directly fronting the N7 National Primary Route. The proposed development and the additional traffic movements generated would therefore be contrary to the proper planning and development of the area
- 2. The proposed development would result in the further encroachment of warehousing/haulage use in an area of the site reserved free from development by way of conditions attached to previous planning permissions. The proposed development would therefore contravene materially condition number 5 attached to planning permission register reference number 93A/0634, conditions numbers 10 and 11 of planning permission register reference number 92A/1457 and condition number 9 of planning permission 92A/0515.
- The proposed development would endanger public safety by reason of traffic hazard, as the site is located at a point on the N7 where traffic volumes are high where the general speed limit of 60 miles per hour applies and where traffic from the city direction accessing the site and traffic exiting the site for the direction of Naas must undertake hazardous turning movements.
