## Reasons

- The proposed development constitutes overdevelopment of the site and is substandard, with the rear garden of the house in the north part of the site (nearest to number 77) having less than the required private open space to the rear as per Section 3.4.16 'Private Open Space' in the South Dublin County Development Plan (1998). Thus the proposed development would seriously injure the amenities of property in the vicinity and would be contrary to the proper planning and development of the area.
- The proposed development would infringe an existing building line by not maintaining the existing front building line, which is specified in Section 3.4.13.1 of the South Dublin County Development Plan (1998). Thus the proposed development would be contrary to the proper planning and development of the area.
- The setting back of the houses from the existing front building line will impact adversely on the character of the existing streetscape, which is contrary to Section 3.4.13.i of the South Dublin County Development Plan (1998).
