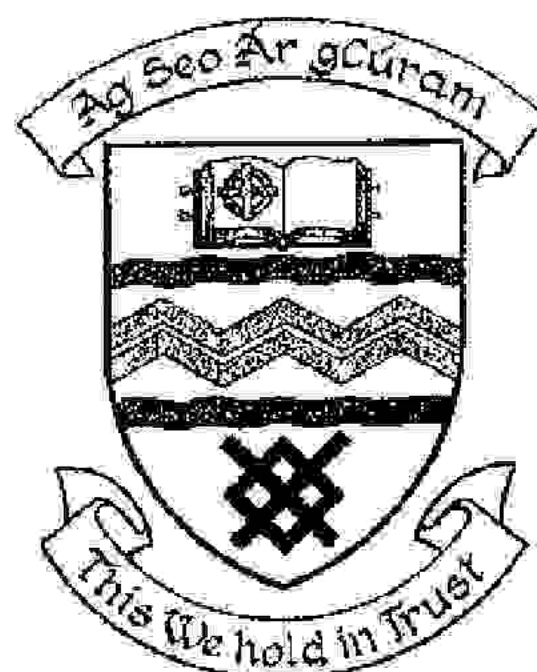

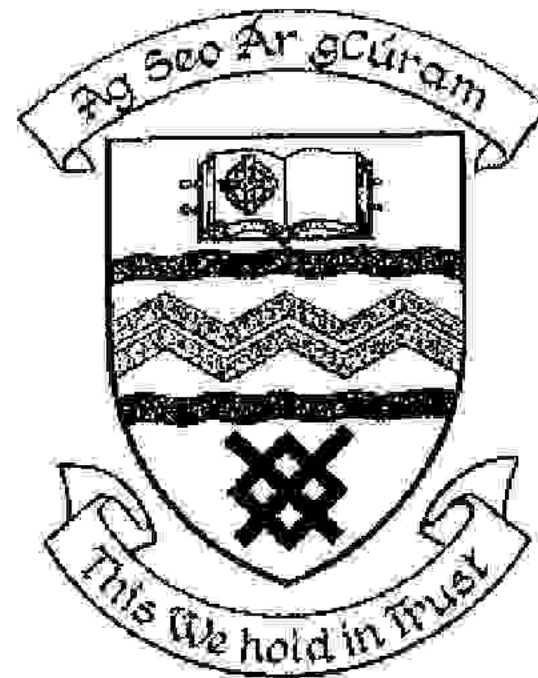
- 1 The applicant is requested to submit details of the location of the Camac River Culvert, running under the existing building, on a revised site layout. The applicant is advised that no part of the proposed new building shall be located within 5m of any part of this culvert.
- 2 The applicant is requested to submit a report from a suitably qualified person/firm, assessing the impact of the new building on the structural integrity of the Camac culvert. Full details of the foundation for the proposed building shall also be submitted. The applicant is advised to consult with the Environmental Services Department prior to submitting additional information.
