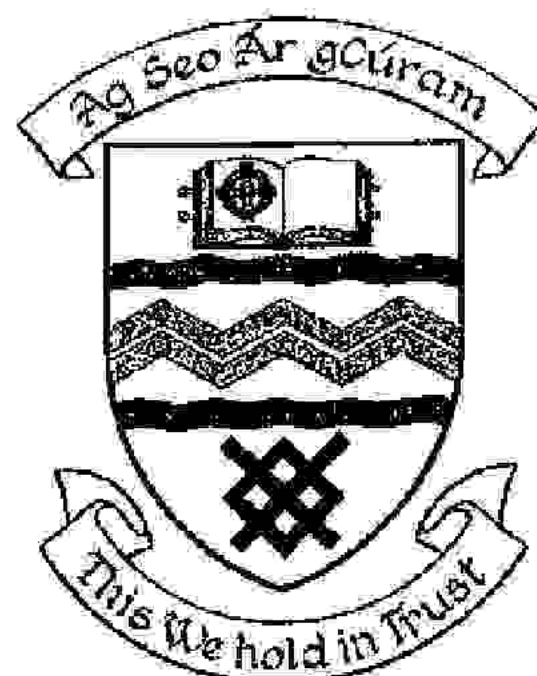

With reference to your planning application, received on 04/12/01 in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning & Development) Acts 1963-1999 and the Planning and Development Act 2000, the following **ADDITIONAL INFORMATION** must be submitted in quadruplicate:

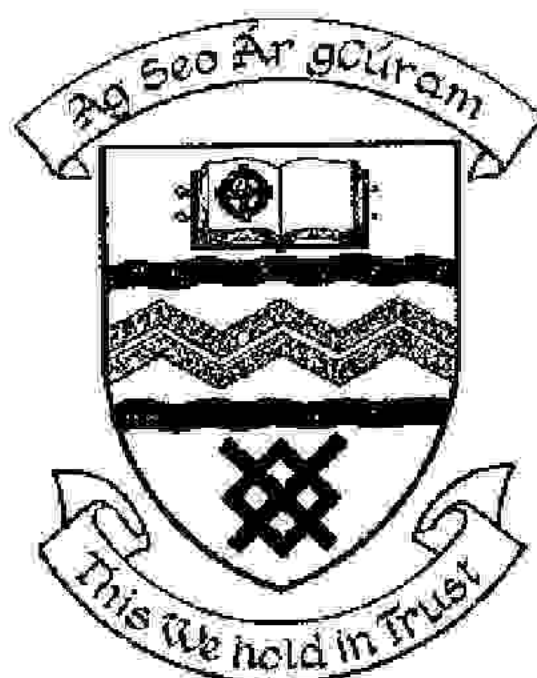
- 1 The applicant is requested to clarify what precise function(s) the structure proposed for retention currently serves, or is proposed to serve. The applicant is also requested to submit revised floor plans of the said structure clearly defining the use of the floorspace throughout the structure. The revised floor plans should also show the location of any sanitary facilities such as toilets, sinks, etc.
- 2 The applicant is requested to submit floor plans of the entire premises in his ownership (i.e. that area outlined in blue and in red on the site location map). The floorplans should be clearly labelled to clarify the precise nature of the uses throughout the premises.
- 3 The applicant is requested to submit foul and surface water drainage plans accurately showing the location of all drains, manholes, AJs etc. located within the site boundary up to the point of connection with the public sewers. This
