

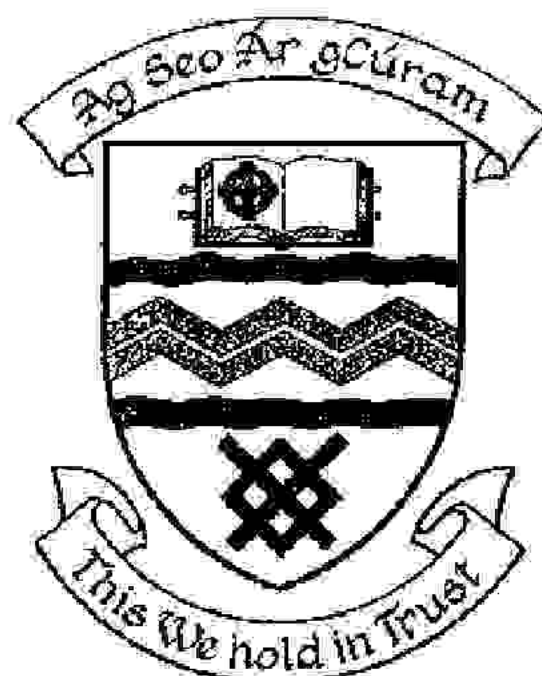

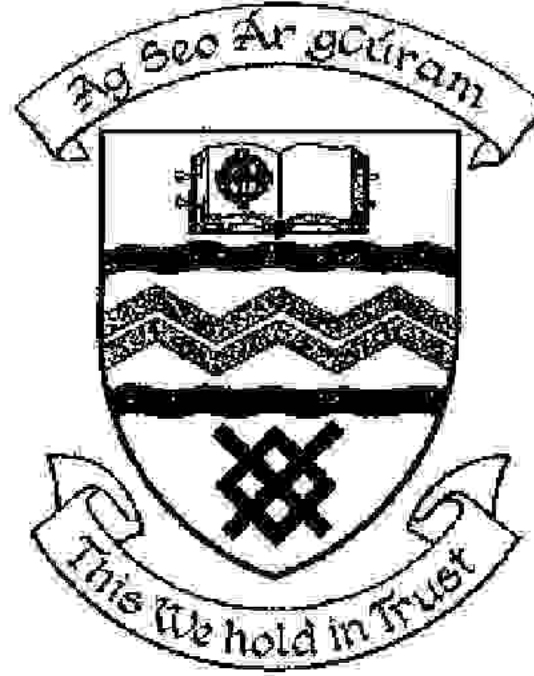

Conditions and Reasons

- 1 The development to be carried out in its entirety in accordance with the plans, particulars and specifications lodged with the application, save as may be required by the other conditions attached hereto.

REASON:

To ensure that the development shall be in accordance with the permission and that effective control be maintained.

- 2 The site of the proposed Automatic Teller Machine shall be lit during the hours of darkness.

REASON:

In the interest of the proper planning and development of the area.

- 3 The applicant shall ensure that the automatic teller machine (ATM) meets the following requirements:

- (a) is at a height which ensures that the (ATM) is wheelchair accessible to disabled persons
- (b) To provide dishing of the kerb or a ramp from the car parking area to ensure the automatic teller machine is wheelchair accessible from the car park area. Any dishing of the kerb or ramp shall be to the specifications of the area engineer.

REASON:

In the interest of proper planning and development of the area.

NOTE: The proposed foliage to the south of the automatic teller machine (ATM) should preferably not exceed 1.0 metre in height to ensure the visibility of the ATM from the entrance to the restaurant/bar in the interest of security.
